India, Vietnam, Indonesia, Turkey, Bangladesh, Sri Lanka, China, Iran, Afghanistan, Iraq, American Samoa, Somalia, Botswana, Lebanon, Syria, United States Virgin Islands, Cuba, Sudan, Haiti, Yemen, Pakistan and banned countries.

4. New clients must open a new live account (not a “demo” account) with Ultima Markets. 5. To be eligible for this promotion, clients must opt-in to be part of it by confirming their decision via the client portal.
6. Eligible clients will receive the following credit bonus:
 - a. 50% of your first deposit: credit bonus is capped at 500 USD (or equivalent)
 - b. 10% of your subsequent deposits: credit bonus is capped at 19,500 USD (or equivalent)

\$500	$\$500 \times 50\% = \250
\$1000	$\$1000 \times 50\% = \500
\$5000	$\$1000 \times 50\% + \$4000 \times 10\% = \$900$

7. The total Credit Bonus is capped at 20,000 USD (or currency equivalent) per eligible client at any time during this promotion.
8. Internal transfers, balance or cash adjustments, introducer/affiliate rebates, or commissions are not considered new deposits and are not eligible for this promotion.
