DURATION

The Campaign commences on September 1, 2025, at 00:00 (GMT+3) and remains effective until further notice on the official website (the "Campaign Period").

The actual campaign period shall be subject to the time displayed in the designated promotional campaign area.

ELIGIBILITY CRITERIA

1. This Campaign is open to new and existing clients of Ultima Markets residing in non-restricted countries/regions only. By participating in this Campaign, the client acknowledge that they have read and agreed to be bound by the Terms and Conditions herewith and Ultima Markets' General Terms and Conditions.

Restricted countries/regions: India, Vietnam, Turkey, Bangladesh, Sri Lanka, China, Iran, Afghanistan, Iraq, American Samoa, Somalia, Botswana, Lebanon, Syria, United States Virgin Islands, Cuba, Sudan, Haiti, Yemen, Pakistan.

2. To become a new client of Ultima Markets, it is necessary to register with Ultima Markets, provide all relevant information upon request as part of "KYC" (Know Your Customer) process and create a Live Account.
3. This Campaign is applicable to all types of Live Accounts.
4. To participate in this Campaign, clients must opt-in via designated promotion section in the Ultima Markets' client portal.
5. New clients are required to register an account with Ultima Markets prior to opt-in for this Campaign.

CAMPAIGN MECHANICS

6. During the Campaign Period, clients who close profitable trading orders will receive an additional 1% + 0.5%* of the order's profit as a rebate, calculated after deducting commissions and other applicable fees (such as swap fees). Details are as follows:
 - a. *Existing "Extra 1% " campaign (1%) + "Winning Bonus" campaign (0.5%), totalling 1.5% additional rebate.
7. Calculation Method
 - a. Rebate Amount =
 $(\text{Profit per closed order} - \text{Commission} - \text{Other fees}) \times \text{Additional rebate percentage (\%)}$
 - b. Client A opens a 1 lot USD/JPY trade with a commission of \$5. The position is closed the next day with a profit of \$100, and the overnight interest fee is \$0.20. Client A's trading account will be entitled to receive approximately \$1.42 $[(100 \text{ USD} - 5.20 \text{ USD}) \times 1.5\%]$ at around 05:00 (GMT+3).
8. This Campaign is only applicable to trading orders with the following products: Forex, Gold, Silver, Crude Oil.
9. All trading orders are calculated for rebate amounts daily at approximately 05:00 (GMT+3) based on closed profitable trades.
10. During this campaign period, the total rebate bonus cap for each eligible client is \$200 USD (or equivalent currency).
11. Profit surplus obtained from this campaign will not be included in the profit-sharing calculations for PAMM, MAM, and Copy Trading.

15. Only trading orders with an interval of more than 5 minutes between opening and closing positions are eligible for campaign rewards.

16. All open positions must be closed on the last day of the campaign period. Any positions that remain open after the campaign ends will not be included in the campaign rewards.

17. The Company reserves the right to determine at its sole discretion whether certain trades, practices, strategies, or scenarios violate the intended purpose of the campaign and may immediately disqualify clients from eligibility without prior notice.
