Duration

The Campaign commences on December 15, 2025, at 00:00 (GMT+2) until January 09, 2026, at 23:59 (GMT+2)

The actual campaign period shall be subject to the time displayed in the designated promotional campaign area.

Eligibility Criteria

- 1. This Campaign is open to new and existing clients of Ultima Markets residing in Europe, Latin America and Taiwan. By participating in this Campaign, the client acknowledge that they have read and agreed to be bound by the Terms and Conditions herewith and Ultima Markets' General Terms and Conditions.
- 2. New clients are required to register an account with Ultima Markets prior to opt-in for this Campaign.
